# Finance Report:

# Banquet Update:

### Update on the Race Schedule:

The schedule is tentative starting the first race on Dec. 12, 2004. Three dates are confirmed. Handicap System:

Jim Fisher made a motion to change the handicaps for the 2004-2005 season as follows:

Calculate separate slalom and GS season handicaps. Use the slalom season handicaps in calculating the Elite par in slalom races and the GS season handicaps in calculating the Elite par in GS races. Run order and all other uses of the season handicap would be based on the slalom season handicap because we have more slalom races than GS.

Seconded by Scott Stern. Motion passed.

Jim then made the following motion:

Season Handicaps that compute to less than 1 shall be set to 1.0 (i.e, no one shall have a season handicap less than 1.0 at any time).

Seconded by Brad Butzke. Motion passed.

Scott Stern made a motion to change end of season point total for the 2004-2005 season to be best three (3) slalom races and best three (3) GS races. Seconded by Brad Butzke.

Motion tabled until next meeting.

### Equipment:

Scott proposed replacing all gates and selling the old gates at &10.00 each. Would nedd about \$2000.00 to buy the new gates.

John Mack made a motion to buy new gates to replace the old ones. Seconded by Jim Fisher.

Motion passed.

#### Run Order:
